

SAFETY GUIDELINES FOR NON-HAZARDOUS FINISHED GOODS

GENERAL INFORMATION

TRADE NAME:..... Kem Tek Tile & Spa Cleaner SKU # 319
ACTIVE CHEMICAL NAME:..... Citric Acid 17% and Muriatic Acid 2%
ACTIVE CHEMICAL FORMULA:..... C₇H₈O₇ + HCl

FIRST AID

SKIN:..... Flush thoroughly with water. If irritation persists, call a physician.

EYES:..... Flush thoroughly with water. If irritation persists, call a physician.

SWALLOWED:..... Do not induce vomiting. Give large quantities of water or milk. Call POISON CENTER or a physician.

HAZARD INFORMATION

FIRE AND EXPLOSION:..... Non-Hazardous; emits acid fumes when exposed to fire.

INHALATION:..... Non-Hazardous

PRECAUTION/PROCEDURES

NORMAL HANDLING:..... Avoid contact with contents. Do not puncture. Keep upright. If package is damaged, contact supplier.

STORAGE:..... Do not stack more than 8 cases high (palletized). Do not store on elevated racks. Do not stack with other chemicals. Store in a dry place away from direct sunlight or heat.

ROTATE STOCK

PRECAUTIONARY LABEL:..... Irritant

SMALL SPILLS/LEAKS:..... May be absorbed with a spill kit. If unavailable, flush with copious amounts of water into sewage. May be neutralized with "Baking Soda" (sodium bicarbonate) before flushing to minimize possible damage.

PERSONAL PROTECTIVE EQUIPMENT

EYES AND FACE:..... Glasses, or goggles are recommended.

HANDS, ARMS, AND BODY:... Plastic/rubber glove are recommended.

PHYSICAL DATA

MATERIAL:..... Thick liquid

APPEARANCE:..... Orange, slightly opaque

STABILITY:..... Excellent with proper storage.

INCOMPATIBILITY:..... Strong Oxidizer, ammonia, bleach and other household products.

SHELF LIFE:..... 1 year minimum

ENVIRONMENTAL

DEGRADABILITY:..... Does not degrade when proper stored.

WASTE DISPOSAL:..... Contact supplier or proper authority for local disposal regulations.
